The Rider may call 9-1-1 and request a transport back to the Department.</p>

It is further understood that the undersigned agrees to hold the Port Gamble S'Klallam Tribe and its employees and agents free from any claims or damages arising from or associated with the participation activity.

It is further understood and agreed that the undersigned shall fully comply with any order or instruction given by any member of the Department of Public Safety. The Port Gamble S'Klallam Department of Public Safety shall make every reasonable effort to reduce the risk of any possible pending injury or death to the undersigned.
