

**PGST YOUTH SERVICES  
DRIVER'S EDUCATION APPLICATION**

**Port Gamble Youth Services provides Driver's Education Assistance to Port Gamble S'Klallam Youth age 15-18. In accordance with Port Gamble S'Klallam Tribe General Welfare Assistance Programs, assistance will be awarded to the following:**

- Youth in K-12<sup>th</sup> grade actively enrolled in school and/or Toddlers/Pre-School age AND
- An enrolled member of the Port Gamble S'Klallam Tribe OR
- An un-enrolled, direct descendent child of a Port Gamble S'Klallam Tribal member attending or residing within NKSD Boundaries OR
- Youth residents of tribal families permanently living on the Port Gamble S'Klallam Reservation.  
*\* Youth enrolled in another tribe must provide written verification from their tribe certifying that they are not eligible to receive financial assistance for extra-curricular activities and/or driver's education course fees. Youth whose enrolled Tribe provides support for these activities are not eligible to receive assistance from the Port Gamble S'Klallam Tribe.*

The Port Gamble S'Klallam Youth Services Program assists families in a partial payment for the cost of an approved Driver's Education course. It is the discretion of the family where and when they choose to take the course.

To enroll in Driver's Education youth must be age 15-18. Youth Services will only assist in the \$300 payment assistance one time per youth.
